



**LETTER OF AGREEMENT (LOA)**

**BETWEEN**

**FACULTY OF POLITICAL AND SOCIAL SCIENCES, UNIVERSITY OF JAMBI,  
INDONESIA**

**AND**

**FACULTY OF SOCIAL WORK AND SOCIAL WELFARE  
HUACHIEW CHALERMPRAKIET UNIVERSITY, THAILAND**

In order to foster academic and research cooperation in the field of social work, social welfare, political science and social science between Faculty of Social Work And Social Welfare Huachiew Chalermprakiet University, THAILAND and Faculty of Political and Social Science University of Jambi (Unja), INDONESIA, the two Institutions have concluded this Letter of Agreement (LoA) to the following framework based upon principles of mutual equality and reciprocity of benefits;

1. Both parties hereby agree to encourage academic cooperation through social work, social welfare including political and social science research and study in furtherance of the advancement of learning and researching in the field of the said disciplines by taking actions as stated below,
  - (a) To encourage visits by faculty members and/or students from one university to the other for the purpose of engaging research,
  - (b) To facilitate faculty members and/or students of both parties to do their research and visit the campus including library of both parties.
  - (c) To foster the exchange of academic publications and scholarly information including research papers, academic bulletin, or relevant academic papers in the field of political and social issues where possible and appropriate
  - (d) To promote other academic activities which enhance the purposes of this LoA as mentioned above.

2. Both parties will seek opportunities to cooperate in variety of political and social teaching areas, including faculty development.
3. Both parties agree that all expenses, including research material, international and domestic travel, per diem, honorarium and all other costs, shall be the responsibility of the participating scholars, unless otherwise agreed, and shall be determined on a case-by-case basis. However, each party of this LoA will make its best efforts to make available university accommodation to visiting-faculty members and/or students of each party.
4. The crests and logos of the two institutions are the intellectual property of both parties, and may not be used without the written permission of the institution that owns a particular crest or logo.
5. Both parties agree to review this LoA after five years following the date of signature, and acknowledge that this LoA is subject to revision or termination at any time by written agreement between both parties or by 90 days from the date of the receipt of the written notification made by either party.
6. Subject to other subsequent Agreements, both parties agree that this LoA is incorporated into, and will provide the foundation and framework for, projects developed by academic staffs and administrative units of both parties.
7. This LoA is entered into force immediately and unconditionally on the date of signature of both parties.
