

MEMORANDUM OF UNDERSTANDING

BETWEEN

UNIVERSITY OF THE PHILIPPINES LOS BAÑOS
COLLEGE, LAGUNA, PHILIPPINES



AND

UNIVERSITY OF JAMBI
JAMBI PROVINCE, SUMATERA, INDONESIA



The **UNIVERSITY OF THE PHILIPPINES LOS BAÑOS**, and **UNIVERSITY OF JAMBI** recognizing the benefits to their respective universities from the establishment of institutional links, conclude this agreement.


1. The purpose of this Agreement is to develop academic and educational cooperation and promote mutual understanding between the two universities.
2. Both universities agree to develop the following collaborative activities in academic areas of interest, on a basis of equality and reciprocity:
 - a. Exchange of faculty, researchers and other research and administrative staff;
 - b. Exchange of students;
 - c. Conduct of collaborative research projects;
 - d. Conduct of lectures and symposia;
 - e. Exchange of academic information and materials; and
 - f. Other activities that will be agreed upon.
3. The development and implementation of specific activities based on this Agreement will be separately negotiated and agreed upon between the faculties, schools or institutes which carry out these activities in accordance with the laws and regulations of the respective countries after full consultation and approval.
4. It is understood that the implementation of any of the types of cooperation stated in clause 2 may be restricted depending upon the availability of resources and financial support at the universities concerned.
5. All collaborative activities and exchanges under this general MOU shall not be conducted or enforced unless a specific Activity Agreement is executed between the parties herein observing the same formalities and all limitations specified herein.
6. Nothing shall diminish the full autonomy of either institution, nor will any constraints be imposed by either upon the other in carrying out the agreement.
7. Subject to the governing law of each institution's jurisdiction regarding public records, the universities agree not to use or disclose to anyone information belonging to the other party which is disclosed in connection with this Agreement which is of

confidential nature and agree not to make any announcements of any nature in respect to this Agreement without the consent of the other party hereto.

8. This agreement may be amended or modified by a written agreement signed by the representatives of both universities.
9. Within 30 days from the effectivity of this agreement, each party shall inform the other party in writing the name of its staff/office who/which will serve as its liaison officer/office with the other party under this agreement.
10. This agreement is valid for a period of five (5) years from the date of signing by the representatives of both universities. This agreement may be renewed subject to the review and renegotiation by both parties. Such review and negotiation shall be conducted within sixty (60) days prior to the expiration of the agreement.
11. This Agreement may, at any time during its period of validity, be terminated by one of the universities, upon prior notice to the other in writing not later than six (6) months before the termination date.
12. This Agreement shall be executed in English.
